- 1.3.1.2. Referenced Documents List updated -Note that some referenced documents may have been upgraded to a more recent version, NFPA 10, 25, ULC S536 etc.
- 2.1.3.8. Commissioning of Life Safety & Fire Protection Systems.
- 2.1.5.1. Specific standards referenced for portable extinguishers

- 2.4.1.1. Allowance for abandoned wiring in ceilings if space is sprinklered.
- 2.6.1.9. (2) Fixed pipe fire suppression systems may be permitted to be serviced annually instead of semi-annually.
  Individual facilities must apply to the OFM for this exemption. Determined on a case by case basis.

- 5.6.1.1. All sections of 5.6 now apply during construction, alterations or demolition.
- 5.6.1.2. Code now identifies adjacent buildings and structures require protection.
- 5.6.1.4. Access for firefighters throughout during construction required.

- 5.6.1.8. Specific requirements for ignition sources at construction, alteration or demolition sites.
- 5.6.1.9. Requirement for coordination with services providers during demolition.
- 5.6.1.13. Requirement to maintain fire protection systems when possible or shut down in accordance with NFC 6.1.1.4.

- 5.6.1.14. Fire watches to ensure warning to occupants is sounded.
- 5.6.1.17. Fire warning system for entire facility needs to be provided.

## Relaxed code requirements

• 6.4.1.1. (1) Hose located in hose cabinets may be removed from service and replaced with a portable extinguisher. Standpipe connections in the cabinets must continue to be maintained in accordance with NFPA 25. Individual facilities must apply to the OFM for this exemption. Determined on a case by case basis.

#### **Current OFM Inspection Process**

- The Office of the Fire Marshal is currently moving toward conducting Hospital inspections every 3 years.
- Nursing homes and other long term care facilities are inspected annually.
- These inspections are full fire and life safety inspections (including maintenance records audits.)

- Required inspections on fire protection systems being fulfilled.
- Monthly, quarterly and semi-annual inspections of life safety systems not always in place.
- Changes or alterations to fire protection systems without proper verification and/or commissioning.

- Regular inspection, testing and maintenance of fire rated doors.
- Penetrations of wiring, piping and ducting through fire separations not being properly sealed and maintained.
- Required fire compartments either not in place or not being properly maintained.

- Decorative materials, draperies, linens, etc. not meeting the required standards.
- Storage, STORAGE, <u>STORAGE</u>!
- Storage in corridors, stairwells, other means of egress.
- Proper use and storage of dangerous goods, oxygen, gas, etc.


- Proper maintenance of access to building, fire department connection, etc. (snow)
- Clearly defined, well signed, unobstructed means of egress.
- Proper maintenance and testing of emergency power systems.

- Adequate fire safety planning
  - Proper plans in place
  - Sufficient staffing to carry out plan
  - Proper postings of floor plans and procedures
  - Adequate and effective fire exercising
  - Complete and effective maintenance plan
  - Effective review

- Plans for construction projects not being submitted to OFM for review.
- Proper fire safety processes not being carried out during construction.
  - Required fire separations in place.
  - Maintenance of fire protection systems.
  - Update of fire safety plan.
  - Adequate hot works processes.
