Professional Development Report May 3, 2022

Medical Gas

There was a large uptake on the Medical Gas Course earlier in the year when it was launched, particularly from Ontario. The ON Government also announced they would provide funding for people in Ontario to take training sessions, which led to increased registration partway through the year. It is not clear if there was a timeline on the funding. Training has not yet been mandated in the Maritimes. The online module is available through CSA.

CanHCC

A new contract has been negotiated with Faculty and a one-year agreement has been signed. The program is being reviewed and Gordon Burrill has been contracted to update the program slides. A further full rewrite of the program, which would include and online module portion, has been delayed for further review in the fall. Estimated costs for this revamp are in the \$100,000 range. Upcoming course date will be announced after slide review.

Certification program

Contract with Mohawk College for exam administration is in progress. A full question review was done by the Advisory Panel.

The National Board executive have committed to take the sample exam and providing feedback to the panel. George Pankiw has developed an outline for an exam study group with the hope to introduce in the fall. Promotion of the program is ongoing. Articles have been developed for Canadian Healthcare Facilities and Canadian College of Healthcare Leaders journals. Craig Doerksen presented a webinar on the program, which was well attended. BC, Manitoba and Maritime Chapters have offered various type of financial assistance to encourage their members to participate.
