

## SICKKIDS PROTOCOLS FOR CHES TOUR

SickKids treats the sickest of the sick in paediatric patients in our facility. As such, we take Covid-19 precautions seriously and in many cases are more restrictive than other organizations or government mandates. For this reason, we have strict protocols for staff, families, and visitors to our facilities.

We have consulted with our Infection and Prevention Control group and will be limited in terms of site tours to the PGCRL (Research and Learning Tower) and to the more public spaces of our main campus Atrium and Annex buildings, primarily our Main Floor. As such, we will be restricted to provide a tour of select clinical spaces in our presentation.

There are certain protocols and restrictions that will be applicable to those that will be attending the session at SickKids and the tour as follows. Please review this document as it sets out requirements that visitors must meet in order to be able to participate in the CHES event at SickKids. We hope that this will work for your event.

### Vaccination Compliance Mandate:

SickKids requires that all individuals coming on site to any SickKids premises must be fully immunized. An individual is fully immunized 14 days after receiving their second dose of a two-dose vaccine series, or one dose of a single-dose vaccine series, that is listed for emergency use by the World Health Organization or approved by Health Canada.

- Attendees must follow hospital masking protocols. Masks, supplied by SickKids, must be worn indoors.
- Attendees must complete an attestation form - **Visit SickKids.ca/Covid-19** ([COVID-19 Information | SickKids](#)) self- screening online and obtain your Covid visitor pass. Attendees should screen shot the Confirmation numbers and will be required to present details if asked.
- Attendees, that have tested positive for COVID-19 within the last 10 days should not attend the event
- Attendees, that had close contact or lived with somebody that is positive for COVID-19 and/or has symptoms of COVID-19 within the last 10 days
- Attendees shall have not travelled outside of Canada in the last 14 days
- Attendees, that have any symptoms associated with COVID-19 should not attend the event
- Attendees, must not be feeling any symptoms related to COVID-19 (free of respiratory illness symptoms)
- Attendees, that feel any symptoms within 14 days of the event shall advise the organizer.

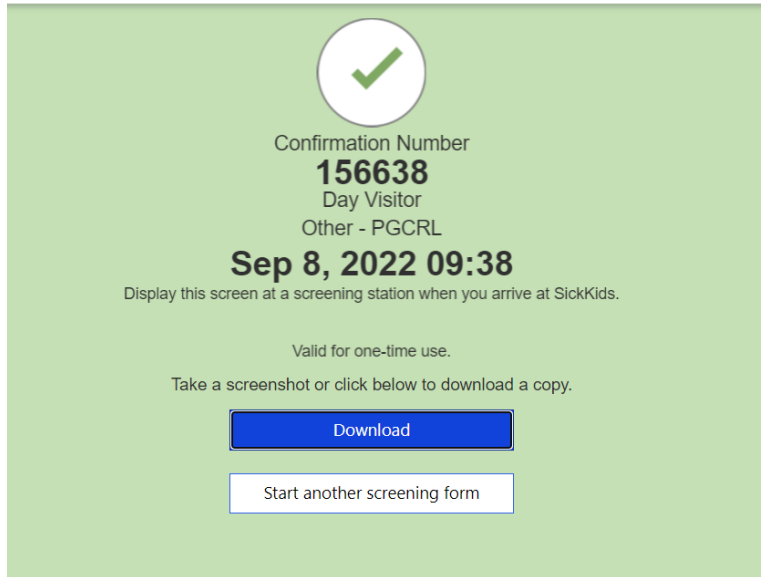
